**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF SAN MIGUEL COUNTY, COLORADO
CONCERNING THE TEMPORARY CLOSURE
OF A PORTION OF
SAN MIGUEL COUNTY ROAD K68**

Resolution #2020-

WHEREAS, the San Miguel County Board of County Commissioners (“BOCC”) have received a request from Ryan Righetti, the San Miguel County Road and Bridge Director, for the temporary closure of a portion County Road K68, also known as Tomboy Road, Forest Service Road 869 or C.R. K68 (“CR K68/FS 869”) to public, motor vehicle traffic due to low accumulated snowpack and an attempt to mitigating damage to the road; and

WHEREAS, Megan Eno, Norwood District Ranger for the Grand Mesa, Uncompahgre and Gunnison National Forest, has additionally advised the County that CR K68/FS 869 is closed to public motor vehicle traffic through May 16, 2020 according to their travel plan (Exhibit A); and

WHEREAS, Mr. Righetti has advised the BOCC that CR K68/FS 869 does not receive winter maintenance and because of low levels of accumulated snowpack in the Telluride region, motor vehicles have been traveling on it. As the result of the current climatic conditions, the operation of motor vehicles has caused and appears likely to result in further serious damage to the road necessitating its temporary closure to public motor vehicle traffic until conditions of the road surface become stable, or the road is able to be reopened to public motor vehicle traffic without such traffic proximately causing damage to the road (Exhibit B); and,

WHEREAS, the portion of CR K68/FS 869 requested for temporary closure begins at the point where it passes the boundary of the Town of Telluride and continues for a distance of approximately 7.11 miles to Ouray County; and,

WHEREAS, CRS § 42-4-106(1) authorizes the BOCC to temporarily close roads on the county system for a total period not to exceed ninety (90) days in any one calendar year, whenever any said road by reason of deterioration, rain, snow, or other climatic conditions will be seriously damaged or destroyed unless the use of vehicles thereon is prohibited or the permissible weights of such vehicles is reduced; and,

WHEREAS, the San Miguel County Board of County Commissioners does hereby find that the current condition of that section of CR K68/FS 869 beginning at the boundary of the Town of Telluride and continuing for a distance of approximately 7.11 miles to the boundary of Ouray County, is such that by reason of deterioration, rain, snow, or other climatic conditions, it would be seriously damaged or destroyed unless the use of motor vehicles thereon, as well as motorcycles, by the public, is prohibited for a period of time not to exceed ninety (90) days from the adoption of this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE SAN MIGUEL COUNTY BOARD OF COMMISSIONERS AS FOLLOWS:

1. Pursuant to CRS § 42-4-106(1), that section of CR K68/FS 869 beginning at the boundary of the Town of Telluride and continuing in an easterly direction for a distance of approximately 7.11 miles to the boundary of Ouray County, is temporarily closed to all public motor vehicle traffic, as well as motorcycle usage by the public, for a period not to exceed ninety (90) days from the adoption of this Resolution or until that section of CR K68/FS 869 becomes passable to motor

vehicles after a determination that the road surface can handle vehicular traffic without causing severe damage, or such temporary closure is rescinded by action of the BOCC prior to the expiration of the ninety-day temporary closure period.

2. The County Road and Bridge Director, in coordination with the Forest Services, is hereby directed to cause the posting of suitable public notices of this temporary closure of the portion of CR K68/FS 869 beginning at the boundary of the Town of Telluride and proceeding in an easterly direction for approximately 7.11 miles to the boundary of Ouray County. The Road and Bridge Director is further directed to periodically inspect, or cause to be inspected, such road closure notices and to cause such notices to be repaired and/or replaced in the event of their damage or destruction during the temporary closure period. Upon the removal of such signage, the temporary road closure authorized by this Resolution shall no longer be in effect.

Re: Temporary closure of CR K68, "Tomboy Rd", FSR 869 to motorized vehicles

Due to the current conditions of the roadway on CR K68 "Tomboy Rd" East of the boundary of the Town of Telluride, Road and Bridge is recommending a temporary closure of the road to motorized vehicles.

This portion of roadway is not maintained through the winter months and is normally covered with snow. Due to the warm weather early in the season, portions of the road have appeared passable to motorized traffic. This year, vehicles have been attempting to travel on the lower section of the road and have caused damage to the road surface. Taking into consideration the time of the year and that routine maintenance will not be performed until late May or early June, along with the high probability of continued spring storms, the road will continue to encounter further damage if vehicular traffic continues until weather and conditions allow for the surface to become stable enough to tolerate motorized traffic. The USFS has current closures to vehicular traffic on those portions of the road that cross Federal Lands until May 16th.

Road and Bridge is recommending to the BOCC that a resolution, consistent with Colorado Statutes restricting the use of highways, temporarily prohibiting motorized vehicles on the Portion of CR K68, at a point beginning from the boundary of the Town of Telluride extending east 7.11 miles to the boundary of Ouray County, for a period not to exceed 90 days or until such time that a determination by the BOCC, or the Superintendent of Road and Bridge, finding the road surface has become stable enough to tolerate motorized traffic, be enacted. CR K68 will remain open to all other, non-motorized means of travel during this time. Signs will be posted and maintained by San Miguel County Road and Bridge informing motorists that this portion is restricted to non-motorized use.
