


What is unique about COVID-19

- It is more contagious and harmful with more fatalities than the flu
- Symptoms range from none to mild to severe or even death
- There are no treatments or vaccines
- Long incubation period
- Lag time in detection
- Asymptomatic cases


Safer at Home Bent the Curve: Number of CO Hospitilizations








Future Need for Herd Immunity










Not out of the woods until we get **Game Changers**

- Widespread TESTING/TRACING capacity quickly detect the disease, isolate
 - At home test kits, rapid testing, quick response time
- Better understanding of IMMUNITY
 - How long does immunity last
 - Can you get COVID-19 again?
 - Herd immunity possible?
- Antiviral Medications can lessen severity and duration of illness
- Vaccines Best case scenario 1+ year out



COVID-19 Indicators to move through phases of public health orders






Triggers to Tighten Measures

If 1 item from 2 out of the 3 columns, measures should be tightened

Epidemiology	Healthcare System	Public Health	
Increase of new case counts that overwhelm the public health system	ICU bed capacity is less than 20 beds in the region	Contact tracing program is unable to meet needs and demand of cases	
	Can no longer screen large numbers of symptomatic patients safely (i.e. outdoor tents, drive through, and staffing)	Symptomatic contacts are unable to get tested in a timely fashion.	
More than 3 unlinked chains of transmission in a 14-day period	Less than 4 weeks supply for PPE for double the current case load	No designated facilities for non-hospitalized COVID-19 infected people who can't be safely cared for at home (i.e. due to medically vulnerable household members, space constraints, or social needs)	
	Insufficient face masks to provide all patients seeking care even if cases double		
Increased number of new healthcare worker infections for 5 consecutive days	Do not have baseline capacity in general health services, including telemedicine for COVID-19 and usual care	Lack of compliance to physical distancing measures.	
	Healthcare facilities can no longer be structured to reduce possibility of exposure at triage and all other locations

COVID 19 Test Types

PCR testing look for active infection

PCR tests goal is to:

- Identify sick and contagious people
- Isolate and contain spread

PCR Tests offered by both clinics

Serology tests look for antibodies in the blood Antibodies are proteins that can fight off infection

IgG typically develops 10-14 days after infection


Serology tests goal is to understand:

- Who is infected
- How it is spreading

Objective of surveillance testing

- Provide incidence of infection
- Guide control measures, such as social distancing

Considerations for Second Round



Emergency Operations Center - SWOT

Strengths

- Multiagency cooperation clear delegation within ICS
- Thorough inventory and site selection
- Open and honest dialogue
- Quick, daily information and news releases
- PPE and supplies preparedness
- Public notification (KOTO, CodeRED, news releases)
- Clinics flex and partnership with public health

Opportunities

- Better communication to all populations (non-English speaking, social media, people without internet)
- Table tops with heightened challenges
- Different workstyles and skillsets
- Educate in emergency response for all organizations and levels

Weaknesses

- Planning was rushed
- Need a facilities manager
- Need for chain of custody
- Results turn around and notification
- Inventory management and burn rate tracking
- Lack of consistent ICS training, roles, and responsibilities
- Weekly expenditures for response

Threats

- Uncertainties and unknowns
- Feeling vulnerable
- Threat perception

Recommendations

- Increase Public Health community-wide PCR testing
- Assess cost and benefits of surveillance sampling vs. community-wide testing
- Define expectations for specificity/sensitivity and validation of a serology test from the FDA
- Reassess in early August future test date for second round
