


## What is unique about COVID-19

- Asymptomatic cases


# Safer at Home Bent the Curve: Number of CO Hospitilizations




## Colorado Residents Today



## Future Need for Herd Immunity








## Not out of the woods until we get **Game Changers**

- Widespread TESTING/TRACING capacity quickly detect the disease, isolate
  - At home test kits, rapid testing, quick response time
- Better understanding of IMMUNITY
  - How long does immunity last
  - Can you get COVID-19 again?
  - Herd immunity possible?
- Antiviral Medications can lessen severity and duration of illness
- <u>Vaccines</u> Best case scenario 1+ year out



## COVID-19 Indicators to move through phases of public health orders






## Triggers to Tighten Measures

If 1 item from 2 out of the 3 columns, measures should be tightened

Epidemiology	Healthcare System	Public Health	
Increase of new case counts that overwhelm the public health system	ICU bed capacity is less than 20 beds in the region	Contact tracing program is unable to meet needs and demand of cases	
	Can no longer screen large numbers of symptomatic patients safely (i.e. outdoor tents, drive through, and staffing)	Symptomatic contacts are unable to get tested in a timely fashion.	
More than 3 unlinked chains of transmission in a 14-day period	Less than 4 weeks supply for PPE for double the current case load	No designated facilities for non-hospitalize COVID-19 infected people who can't be safely cared for at home (i.e. due to medically vulnerable household members, space constraints, or social needs)	
	Insufficient face masks to provide all patients seeking care even if cases double		
Increased number of new healthcare worker infections for 5 consecutive days	Do not have baseline capacity in general health services, including telemedicine for COVID-19 and usual care	Lack of compliance to physical distancing measures.	
	Healthcare facilities can no longer be structured to reduce possibility of exposure at triage and all other locations

Re: Request for Safety Protocol Training Period for Lodging Sector – San Miguel County, Colorado

Dear Mike and Grace,

In follow-up to our conversations from last week regarding the proposed plan to resume short-term lodging operations, we would recommend that we implement a "training" period from 6/1/20 - 6/11/20 to be followed by the phased re-opening as detailed in our proposal starting 6/12/20. We believe the training period will allow us to be better prepared to achieve the goals we have outlined in our proposal for the strategic relaxation of the current Public Health orders to allow a safe, phased re-opening of the Lodging Sector. Specifically, this initial training period would:

- 1. Allow the immediate establishment of the Lodging Oversight Committee which could then begin the process of soliciting and evaluating applications to resume offering lodging products and services. As we begin to review the plans that will be submitted by businesses to safely open, we will learn a lot about the critical paths to re-opening and can share these learnings among the various participating businesses.
- 2. Give us the opportunity to test our communication plan with guests to determine if: 1) We are asking the right questions in a way that solicits the information required by Public Health; 2) The questions raise any red flags with guests regarding privacy or other concerns; and 3) To begin the process managing the incoming data to determine how best to maintain the records in the event they would be needed by Public Health.
- 3. Provide a limited operational scope which can help lodging operators to train staff, answer questions from guests, and work with vendors to be sure we have protocols firmly established prior to moving to a next phase.

We would propose that the initial training period be structured as follows:

- 1. Lodgers would be allowed to service reservations on the books to arrive between 6-1-2020 and 6-11-20. These would be limited to reservations made on or before May 17, 2020 and no other reservations would be allowed to be made for this period.
  - a. The overall STR occupancy in town may not exceed 15%.
  - b. The TTB would act as an aggregator of these reservations to compile the statistics and verify reservations do not exceed the 15% cap.
  - c. Only lodging operators who have submitted a Business Safety Checklist and been approved to operate may service reservations during this period.

- 2. Any lodging businesses that chooses to operate during the training period must commit to the standards as detailed in the Lodging Sector proposal plus the additional safeguards as highlighted in the following:
  - a. All staff temperature and symptom screening to be logged daily.
  - b. Guests must be sent the pre-arrival health screening form in advance of arrival. It is a requirement for occupancy.
  - c. All housekeeping staff must complete the proposed Covid-19 Housekeeping Certification
  - d. There would be no guest contact at either check-in or check-out. No in-person guest interactions would be allowed at the property during the stay unless in the event of emergency.
  - e. During this training period, the following services would not be allowed valet parking, bellman or luggage service, shuttle services, mid-stay housekeeping services, in-person concierge service, non-emergency maintenance services while the guest is in-residence, no common hot-tubs, no common pools, no common area usage such as great rooms, fitness centers, saunas, bbq areas, etc.
  - f. A minimum of 24 hours would be allowed after departure before housekeepers could enter the rooms.
- 3. During these ten days, the LOC would monitor results of new protocols and make recommendations for improvements and changes as warranted

We look forward to discussing these recommendations with you at the earliest opportunity. As always, thank you for your time and commitment to our community.
